The March 2020 budget confirmed this Government strategy setting out the rates for the next 5 years with a cap of just 2% BiK on zero emission cars.
- Employers can make class 1 NI savings on ULEVs. Many EVs can now generate circa £3000 per car in class 1 employer NI savings based on a typical 3 year term.
- ULEVs continue to offer the biggest tax efficiencies to employees and employers. Based on an average savings across EVs, less than 50 EVs can generate circa £100,000 Class 1 employer NI savings.

#### The Process

- 1. Complete flexibility with access to all current makes, models and specifications in the UK market. Terms from 24-48 months, 5-35k miles p.a.
- 2. Access electric and hybrid vehicles as well as lower emission petrol and diesel cars
- 3. Tusker leases the car and funds it to the employer. Employee signs a binding back to back agreement taking on the obligations of the arrangement.
- 4. Employer reduces employee's gross salary in exchange for the benefit of the car. Employee saves tax & NI contributions. The car is a taxable benefit so employee pays tax on BIK
- 5. Employer uses the gross salary sacrified to cover monthly invoice
- 6. It's cost neutral
